## ADMINISTRATIVE FINE AND FEE SCHEDULE

The Golden Municipal Code allows for the issuance of administrative penalties for violations of certain administrative regulations and ordinances. The three levels of penalties indicated below are assessed progressively for such violations.

**1<sup>st</sup> Penalty - \$100.00**

**2<sup>nd</sup> Penalty - \$200.00**

**3<sup>rd</sup> Penalty - \$500.00**

Payment is due in full within 15 calendar days of the Date of Citation. Failure to make the payment listed above within 15 days will result in the imposition of a \$25.00 late fee and interest to accrue at 10% per annum. Payments may be made in cash, credit card, check or money order. A return check fee of \$25.00 will be assessed on all returned checks.

Unless as otherwise specified herein, parking violations set forth in Part 12 of the Model Traffic Code of Colorado ("MTC") as adopted by the City of Golden are subject to a fine of \$30.00.

Payment for parking violations are due within 10 days of issuance. A late fee of \$30.00 shall be assessed upon all fines not paid within the 10-day period.
