Re: Community Sustainability Advisory Board 2023 Work Plan

Mission/Purpose of Board/Commission: The mission of the Community Sustainability Advisory Board is to assist the City of Golden in defining and achieving its sustainability goals and to empower the community to live in a way that assures a high quality of life for current and future generations.

2022 Accomplishments:

- Net Zero Building Codes. The Board led an engagement with the community to discuss potential new building codes to help the City meets its sustainability goals. This included the hiring of two consultants, seating the Energy Code Stakeholder Group and collaborating with Planning Commission. The Board developed a detailed document supporting its four recommended strategies, which was forwarded to Council with joint endorsement from Planning Commission.
- Community Solar. The Board solicited qualified community solar developers and evaluated applicants before sending a
 recommendation to partner with SunShare for potential community solar projects. The board provided initial guidance to
 Sunshare on a potential community subscriber model.
- Greenhouse Gas Emissions Inventory. An update to the City's original study was completed by a consultant in collaboration with the Board. These results have been publicized and integrated into other Board projects.
- Electric Vehicles. The first ever Municipal Fleet Electric Vehicle Master Plan was completed and adopted with initial electric vehicles and chargers coming in 2023.

2023 Board Goals: CSAB discussed near-term and ongoing initiatives at their December 10th annual retreat and January 25th regular meeting and offers the following 2023 CSAB Work Plan for Council's consideration. The Board's priorities for 2023 are divided into three categories: energy, waste and water strategies. The 2023 initiatives are summarized in a table following this memo.
