Mission/Purpose of Board/Commission:

The Golden Urban Renewal Authority assists with the redevelopment of blighted property to help sustainable development thrive. Improving physical conditions contributes to Golden's economic stability and vitality by meeting the goals of the Comprehensive Plan, Golden Vision 2030, City Council Resolution 2161, and all appropriate neighborhood plans.

2022 Accomplishments:

- For the West Colfax Complete Streets infrastructure project, GURA made an additional community investment of \$125,000 to complement previous commitments of \$870,000. In addition, in 2025 and 2026, GURA has budgeted another \$500,000 for the project.
- Continued to focus on expenditures for five active owner participation agreements in the Central Neighborhoods, Parfet-Briarwood, and West Colfax urban renewal areas.
- Continued to seek or respond to redevelopment opportunities, especially for affordable housing.
