

A PORTION OF THE RIGHT-OF-WAY OF U.S. HIGHWAY 6, LOCATED IN THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 3 SOUTH, RANGE 70 WEST OF THE 6TH PRINCIPAL MERIDIAN, JEFFERSON COUNTY, COLORADO BEING DESCRIBED AS FOLLOWS:




