## **Council Memorandum**

Re: Sales, Use, and Lodging Tax Report

Attached are the sales and use tax reports for January sales (collected in February). Sales tax collections were up \$100,075 (+6.9%) for the month. The increase is across many businesses and business types, indicating increased volume of sales, higher prices, or a combination of both. When compared to the 2024 Budget as adjusted for seasonality, revenues are up \$106,198 (+7.3%)

Golden Road and Corporate Center had the largest increases. Downtown and Colfax were both down for the month. Automotive and Business Supplies/Services had the largest increases. Utilities and Grocery were down for the month. Sales from businesses outside the City were up \$28,488 (=2.3%).

Use tax collections were up \$89,163 (+17.7%) for January. Several manufacturers and a utility provider remitted more than usual amounts, with Professional Services and Grocery also up. General Merchandise and Automotive had the largest decreases for the month. Please keep in mind that use tax collections continue to be more sporadic in nature, making trend analysis more difficult and less meaningful.

In addition, \$48,339 in audit revenue and \$28 in permit related fees have been collected so far in 2024. Audit revenue is recorded when it's actually paid vs. when assessed, so these collections reflect payments received in January and February. \$157 have been issued in refunds in January and February, as refunds are recorded when paid. These amounts are shown separately on the attached collection reports.

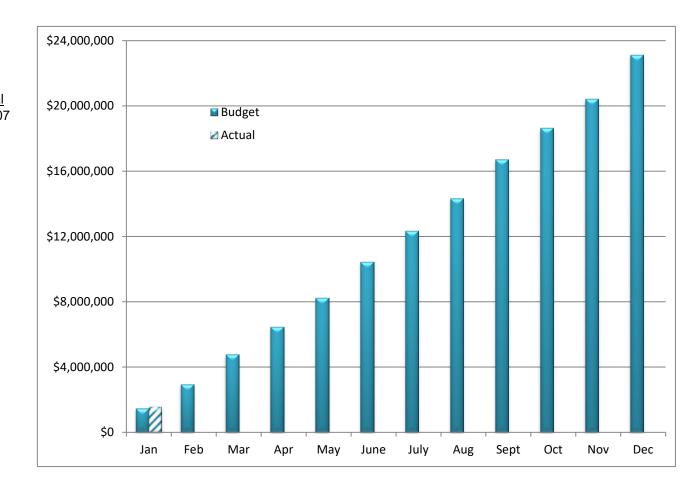
Also, lodging tax collections were up \$16,575 (+13.0%) compared to January 2023, and up 22.2% compared to the 2024 budget. This could also be a reflection of increased hotel stays, increased pricing, or both. Please see the graph at the end of the report that compares lodging tax receipts with the budget for 2024.

While it is obviously too early in the year to draw any conclusions or trends for the year, January taxes have 2024 off to a good start. Inflation appears to be at least a partial factor in the current increase.

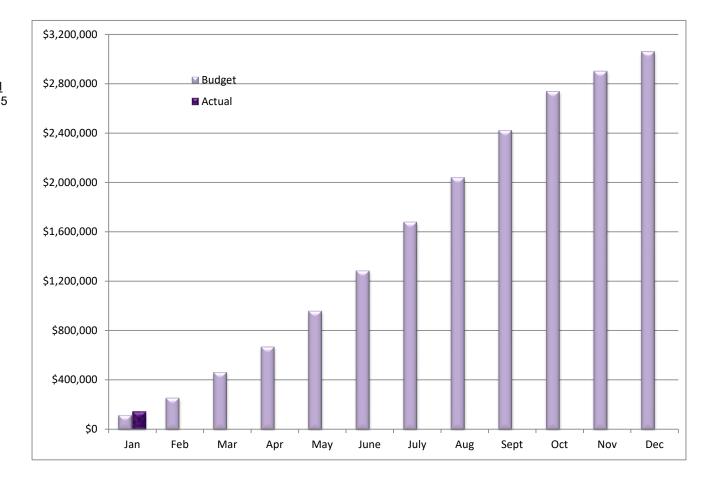
