## **Council Memorandum**

Re: Sales Tax and Lodging Tax Report

Attached are the sales and use tax reports for January sales (collected in February). Sales tax collections were up \$120,714 (+9.9%) for the month. The increase is down somewhat from the 20+% increases in recent months, but still higher than expectations. When compared to the 2022 Budget as adjusted for seasonality, revenues are up \$125,303 (+10.3%)

North Golden and Corporate Center had the largest increases. Downtown and Golden Road had the largest decreases. Utilities and General Merchandise had the largest increases, primarily from utilities to commercial/industrial areas and the on-line retailers. Restaurants and Manufacturing are the business types with the largest decreases for the month. Sales from businesses outside the City were up 10.6%.

Use tax collections were down \$187,457 (-30.6%) for January. This was anticipated as January 2021 was an extraordinarily large month for use tax. The amount for January 2022 was still higher than January 2020 and 2019. Please keep in mind that use tax collections continue to be more sporadic in nature, making trend analysis more difficult and less meaningful.

In addition, \$66,188 in audit revenue and \$3,649 in permit related fees have been collected so far in 2022. Audit revenue is recorded when it's actually paid vs. when assessed, so these collections reflect payments received in January and February. \$0 have been issued in refunds in January and February, as refunds are recorded when paid. These amounts are shown separately on the attached collection reports.


While it is obviously too early in the year to draw any conclusions or trends for the year, January sales and use taxes have 2022 off to a good start.

Also, please note that we received our first month of lodging tax in February for January 2022. For the month, the City received \$58,344 in lodging tax. There are a few hotels and business that did not remit lodging tax for January. We are following up with them and hope to have that resolved when they file their February taxes in March. Please see the graph at the end of the report that compares lodging tax receipts with the budget for 2022.


