Re: Sales Tax Report

Attached are the sales and use tax reports for March sales (collected in April). As expected, sales tax collections were down for the month due to the impacts of COVID-19. Collections were down \$94,306 (-6.5%) for the month. Overall, revenue is up \$38,698 (+1.1%) year-to-date compared to 2019. When adjusted for seasonality, sales tax revenues are down (-1.9%%) compared to the 2020 Budget.

Not surprisingly, restaurants and accommodations have seen the biggest hit to revenues, down 8% and 25% YTD respectively. Also, as expected, Grocery has increased significantly, with King Soopers, Safeway, and Natural grocers all up over 10% compared to last year. In General Merchandise, local retailers (Kohl's, Duluth Trading Company, Bent Gate, etc.) are all down. But, Home Depot and online retailers (Amazon, Wayfair, etc.) are up significantly to help offset the loss from theses local brick and mortar stores.

Use tax collections were down \$52,555 (-15.4%) for March. For the year, use tax is still up \$86,347 (+9.1%) compared to 2019. As has been mentioned in prior reports, use tax can be very sporadic in nature, making trend analysis more difficult. Use tax is generally a sign of businesses reinvesting and upgrading their assets, and can also be a result of the opening of new businesses. We can expect some declines in use tax as most businesses will hold off on reinvesting in their businesses for the foreseeable future. Some of the larger businesses not negatively impacted by the virus will probably continue with current expansions and reinvesting plans. What remains to be seen regarding use tax, is the impact in automotive with dealerships offering discounts and 0% financing on new vehicles.


In the area of audit revenue, \$7,353 was collected in April. Including building use tax audits, the total audit revenue collected for 2020 is \$60,796, with an additional \$2,991 collected in building permit and plan check fees. Also, the City continues to have audits in progress and additional audit revenue has been assessed, with collection anticipated over the next few months. \$2,301 has been issued in refunds for the year. These amounts are shown separately on the attached collection reports.

There were no real surprises in the March numbers as we started to see the impacts of Covid-19. May collections of April revenues will probably show more of the same with some areas seeing a more pronounced increase or decrease. As restrictions start to lift in May, we will hope to see some businesses rebound. These are unchartered times and it's difficult to predict the full extent of the impacts, especially long-term. But we continue to be cautiously optimistic that Golden will recover faster than most of the State and the Country.


