### **Mobile Washing General Permit**

**Fact Sheet and Application for Coverage** 

#### Who Needs Coverage By This Permit?

All businesses or power washing companies performing outdoor washing or cleaning of anything outdoors within Golden City Limits.

#### What Does This Permit Allow?

It allows wastewater from outdoor cleaning activities to be captured and discharged to the sanitary sewer at the property where the washing activity occurred. Discharge may occur through a mop sink, cleanout, or other fixture. Discharge directly into a sanitary sewer manhole is allowable when the cleaning job spans multiple properties or access to the sanitary sewer at the property is not feasible.

#### Why Is This Permit Necessary?

Federal, state, and local laws <u>prohibit</u> anything, except storm water, from entering the storm sewer system, which includes water from outdoor washing and cleaning activities. The storm sewer system directs untreated rainwater and snowmelt into Clear Creek using streets, gutters, inlets and storm drains. This permit allows appropriate disposal of outdoor washing wastewater at the job site.

#### **How Do I Obtain Coverage By The Mobile Washer General Permit?**

Complete the Mobile Washer General Permit Application for Coverage and submit it to Golden's Pretreatment Coordinator, Chris Naber, at <a href="mailto:cnaber@cityofgolden.net">cnaber@cityofgolden.net</a>. Once processed, you will receive a certificate of coverage, a copy of the permit, and a reporting form. This permit is valid until March 31, 2023, at which time the covered business or person must reapply for coverage under the new permit.
