

ORDINANCE NO. 1863

AN ORDINANCE OF THE GOLDEN CITY COUNCIL  
AMENDING CHAPTER 2.50 OF THE GOLDEN MUNICIPAL  
CODE TO CLARIFY THE RESPONSIBILITIES OF THE  
COMMUNITY SUSTAINABILITY ADVISORY BOARD

WHEREAS, the Community Sustainability Advisory Board was created on November 7, 2008 through by Ordinance No. 1789; and

WHEREAS, the Board has been seated since March 2008 and has over time, learned how best to track and recommend strategies to further the city-wide sustainability goals; and

WHEREAS, the Board and City Council find it appropriate to amend the original enacting legislation to better reflect the actual duties and responsibilities of the board, given staff and Board member roles.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Section 2.50.070 (e) "*Monitor and report on the City's internal sustainability and environmental programs. Advise the City Manager on programs to improve that effort and additional efforts and their anticipated results.*" shall be deleted and replaced with the following:

(e) Periodically review the City's internal sustainability and environmental programs to track compliance with the city's energy efficiency, renewable energy, waste, vehicle miles traveled, and water conservation goals. Advise the City Manager on programs to improve current efforts, additional opportunities and their anticipated results.

Section 2. Section 2.50.070 (g) "*Review the designs of all proposed City construction projects and make recommendations for environmental enhancements.*" shall be deleted in its entirety.

Section 3. If any article, section, paragraph, sentence, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision will not affect the validity or constitutionality of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance and each part or parts hereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.

Section 4. All other ordinances or portions thereof inconsistent or conflicting with this ordinance or any portion hereof are hereby repealed to the extent of such inconsistency or conflict.

Section 5. This ordinance is deemed necessary for the protection of the health, welfare and safety of the community.

Section 6. The repeal or modification of any provision of the Municipal Code of the City of Golden by this ordinance shall not release, extinguish, alter, modify or change in whole or in part any penalty, forfeiture or liability, either civil or criminal, which shall have been incurred under such provision. Each provision shall be treated and held as still remaining in force for the purpose of sustaining any and all proper actions, suits, proceedings and prosecutions for enforcement of the penalty,

forfeiture or liability, as well as for the purpose of sustaining any judgment, decree or order which can or may be rendered, entered or made in such actions, suits, proceedings or prosecutions.


