All projects that involve utility boring or that have an anticipated excavation footprint of greater than 2' in depth and a contiguous area of 1000 sf or more shall be required to provide plans that meet or exceed ASCE Quality Level B.

For a single family residence water or sewer service emergency repair, the maximum closure fee is \$75.

B. Street Cut

Inspections: Contractors are required to notify the Public Works Department when Street Cut is backfilled at 303-384-8027.

All Street Cuts are required to be backfilled with Flowfill or Class 6 Road Base per City of Golden Specification #SC-1. All potholes require Flowfill. Failure to do so will result in a \$500 Fee. All asphalt patches and repairs must be done within 5 days of the project's completion.

Contractor will be invoiced after final inspection for variation in cut size. For an emergency repair of an existing water or sewer service line on a single family residence, the maximum fee is \$50 plus the cost of asphalt patch/repair.

*The Street Cut portion is required to be completed for any concrete replacement that is adjacent to a street or alley. A one (1) foot minimum width from the edge of the concrete into the street will be required for this type of work.

Contractors are required to notify the Public Works Department 24 hours before inspection is needed at 303-384-8027. Do not pour concrete until forms have been inspected and approved by the Public Works Inspector. All asphalt patches and repairs must be done within 5 days of the project's completion. All construction shall be Portland Cement Concrete, CDOT Class D unless alternate material is specifically approved by the City Engineer.
