

## RESOLUTION NO. 2228

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLDEN ESTABLISHING COUNCIL'S REGULAR BUSINESS MEETING AND REGULAR STUDY SESSION SCHEDULE FOR 2013

WHEREAS, in accordance with its Rules of Procedure, Council is to establish by resolution its annual schedules for regular business meetings and regular study session; and

WHEREAS, the Charter of the City of Golden (Section 5.1) requires that "The council shall meet regularly at least twice each month at a day and hour to be fixed by the rules of council"; and

WHEREAS, City Council has traditionally met for these regular business meeting on the 2<sup>nd</sup> and 4<sup>th</sup> Thursdays of each month; and

WHEREAS, there are important outside functions that often require a change to that traditional schedule; and

WHEREAS, members of council are actively involved with many community organizations and meetings that require a significant time commitment.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Council establishes the meeting schedule for 2013 as attached to this resolution.

Section 2. Council establishes the normal starting time for all council meetings as 6:30 pm.

Section 3. Council recognizes that the attached schedule includes only two separate study sessions:

- a. Thursday January 17, 2014 to set broad policy direction for 2013; and
- b. Thursday October 17, 2013 to review the City Manager's proposed 2014 budget in depth.

Section 4. Council will establish other study sessions throughout 2013 as required by developing issues and opportunities. These study sessions will either be added on to an established regular business meeting or set with appropriate public notice on an open first or third Thursday.

Section 5. Council approves the Regular Business Meeting and Regular Study Session Schedule for 2013 in accordance with the attached schedule.
