WHEREAS, the City Council hereby finds that adoption of the Transition Plan is necessary for the protection of the health, safety, and welfare of the public and desires to adopt the plan.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:


Section 1. The council hereby adopts the March 2023 Americans with Disabilities Act (ADA) Transition Plan for the City of Golden.


