

RESOLUTION NO. 2272

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO, AMENDING SERVICE FEES FOR THE RESIDENTIAL WASTE COLLECTION PROGRAM

WHEREAS, Chapter 4.82 of the Golden Municipal Code, enacted in May 2010, established a residential waste collection program ("Program") which, in part, authorizes the imposition of fees, set by resolution of City Council, upon residents for the collection of residential waste, including single stream recyclable materials; and

WHEREAS, To maintain the economic viability of the Program and as required by the City's Agreement with the Program's service provider, staff annually analyzes the Program's fees to ensure they remain reasonably related to the costs of the services and, having just reviewed the Program's costs, staff recommends that the fees be increased as set forth herein; and

WHEREAS, Staff recommends that City Council concur with staff's conclusion that the container and additional service fees set forth herein are reasonably related to the City's costs incurred in providing the Program's services.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The following fee schedule for the City's residential waste collection program customers shall be effective as of January 1, 2014.

In drive pick-up	\$10.50/month
Carryout and Carryback	\$6.30/month
Carryout only	\$3.15/month
Carryback only	\$3.15/month
Extra trash tags (5)	\$14.00
Cart replacement fee	\$70.00

Section 2. The fee schedule in Section 1 above shall be effective October 1, 2013 as it pertains to compensation to be paid to the City's waste collection contractor. The City will subsidize the payments to the contractor from the general fund for the period from October 1, 2013, through December 31, 2013, to account for the delay in the effective date of the rate increase to customers.

Section 3. The current monthly fee charged to City's residential waste collection program customers for the Green Waste optional service shall remain at \$5.95 per month, however, effective

October 1, 2013 and continuing through December 31, 2014 the fee for such service upon which compensation to the City's waste collection contractor is paid shall be increased to \$7.83 per month. The City will subsidize the payments to the contractor from the general fund for the period from October 1, 2013, through December 31, 2014, to account for such difference.


Section 4. Fees for certain residents of multi-family units shall continue to be determined upon a multiplier of the appropriate waste container size based on the number of units within the multi-family complex.

Section 5. All other fees for the services set forth herein shall be repealed upon the effective date of the fees established in this resolution.


