

RESOLUTION NO. 2432

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
GOLDEN AMENDING SERVICE FEES FOR THE RESIDENTIAL
WASTE COLLECTION PROGRAM**

WHEREAS, Chapter 4.82 of the Golden Municipal Code, enacted in May 2010, established a residential waste collection program ("Program") which, in part, authorizes the imposition of fees, set by Resolution of City Council, upon residents for the collection of residential waste, including single stream recyclable materials; and

WHEREAS, To maintain the economic viability of the Program and as required by the City's agreement with the Program's service provider, staff analyzed the Program's fees to ensure they remain reasonably related to the costs of the services and, having just reviewed the Program's costs in context of a new service provider and final payments for the entire cart inventory, staff recommends that the fees be increased as set forth herein; and

WHEREAS, Staff recommends that City Council concur with staff's conclusion that the cart maintenance fees set forth herein are reasonably related to the City's costs incurred in providing the Program's services.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The following fee schedule for the City's residential waste collection program shall be effective as of September 1, 2015.



32-gallon super saver service	\$6.20
32-gallon service	\$7.50
64-gallon service	\$12.60
96-gallon service	\$19.25
Additional 96-gallon service	\$10.85
<i>Additional Services</i>	<i>Price to Household</i>
Extra trash tag	\$2.00
In-drive pickup	\$4.00
Carryout and Carryback	\$8.50
Carryout only	\$4.25
Carryback only	\$4.25
Cart exchange after 60 days	\$25.00

Section 2. Fees for certain residents of multi-family units shall be determined upon a multiplier of the appropriate waste container size based on the number of units within the multi-family complex.


Section 3. All other fees for the services set forth herein shall be repealed upon the effective date of the fees established in this resolution.
