- D. Sales Tax Report: Staff Reviewed the December Sales Tax Report. "The final 2022 sales and use tax: reports, including December sales (collected in January). Sales tax collections were up 8.1% (+\$198,149) for the month compared to 2021. For the year, sales tax revenues were up 11.6% over 2021 and up 21.1% compared to the 2022 budget. In dollars, 2022 revenues were up from 2021 by \$2,342,289 and were over the 2022 Budget by \$3,910,353. This is the best year in the City's history for sales tax revenue, clearly exceeding expectations." Jeff Hansen CFO
